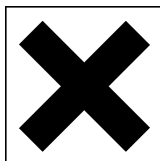

3. Hazards Identification

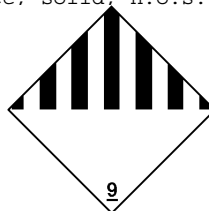

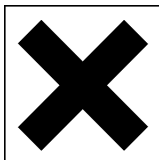
